

TERMS AND CONDITIONS SUMMER CAMPAIGN –2020

There will be the following winners

1. **10 big winners** will win experiences in Cyprus total maximum worth of € 2,000 each. The big winners will have the 2 options of prizes to choose from. There will be 10 runner up winners.
